#### KG1, KG2 & GRADE I

- 1. Original valid Emirates ID of the student + one copy
- 2. Original valid Emirates ID + one copy of the parent who is sponsoring the student.
- 3. Students (KG2 / Grade I) transferred from other schools in U.A.E. except the emirate of Sharjah are required to submit the Transfer Certificate attested from the Ministry of Education.
- 4. Students (KG2 / Grade I) from Sharjah Emirate is required to submit their Daleel number from the previous school.

#### **GRADE II TO IX**

#### 1. Attested Transfer Certificate

- The Transfer Certificate (TC) of the students from outside U.A.E. should be attested from all the following offices:
  - 1. Local educational authority (DEO / Regional Officer, CBSE )
  - 2. The Office of the Indian Consulate, Dubai
  - 3. Ministry of Foreign Affairs in U.A.E.
- The Transfer Certificate (TC) of the students from other Emirates except Sharjah should be attested from the Ministry of Education.
- Students from Sharjah Emirate is required to submit their Daleel number from the previous school.

#### 2. Attested Marklist

#### Grade II to IX

Marklist of the students from within and outside U.A.E. should be attested by the previous school Principal with the school seal.

- 3. Original valid Emirates ID of the student + one copy
- 4. Original valid Emirates ID of the parent who is sponsoring the student + one copy.

#### **GRADE XI**

#### 1. Attested Transfer Certificate

- The Transfer Certificate (TC) of the students from outside U.A.E. should be attested from all the following offices:
  - 1. Local educational authority (DEO / Regional Officer, CBSE )
  - 2. The Office of the Indian Consulate, Dubai
  - 3. Ministry of Foreign Affairs in U.A.E.
- The Transfer Certificate (TC) of the students from other Emirates except Sharjah should be attested from the Ministry of Education.
- Students from Sharjah Emirate is required to submit their Daleel number from the previous school.

#### 2. Grade X Mark list

- Grade X Mark list of students transferred from schools within the Emirate of Sharjah should be attested by the previous school Principal with the school seal.
- Grade X Mark list of students transferred from the other Emirates in U.A.E (except Sharjah) should be attested by the:
  - 1. Previous school Principal with the school seal
  - 2. From the Ministry of Education (U.A.E.) along with the Transfer Certificate.
- Grade X Mark list of the students from outside U.A.E. should be attested from all the following offices:
  - 1. Previous school Principal with the school seal.
  - 2. Local educational authority (DEO / Regional Officer, CBSE )
  - 3. The Office of the Indian Consulate, Dubai
  - 4. Ministry of Foreign Affairs in U.A.E.

#### 3. Equalization of Grade X mark list

Grade X Mark list of the students from outside U.A.E. should be equalized from the Ministry of Education (U.A.E).
